## BAIL BOND RULES

YOU MUST OBSERVE THE FOLLOWING RULES OR YOUR BOND MAY BE REVOKED.  
(PLEASE INITIAL NEXT TO THE NUMBER UPON READING THE RULES)

\_\_\_ 1. YOU MUST PAY YOUR BOND FEE AS AGREED. FAILURE TO DO SO WILL RESULT IN THEFT OF SERVICE CHARGES FILED WITH THE DISTRICT ATTORNEY.

\_\_\_ 2. YOU MUST APPEAR IN COURT AS REQUIRED. FAILURE TO DO SO WILL RESULT IN A WARRANT FOR YOUR ARREST BEING ISSUED, ALSO, SUBJECT TO A POSSIBLE PENALTY OF UP TO 20 YEARS IMPRISONMENT AND/OR A FINE OF \$10,000.00 FOR BOND JUMPING.

\_\_\_ 3. YOU MUST NOTIFY MY OFFICE OF ANY CHANGES IN ADDRESS, PHONE, EMPLOYMENT, ETC.

\_\_\_ 4. YOU MUST RETAIN AN ATTORNEY AND THEN INFORM MY OFFICE OF THE ATTORNEY'S NAME, ADDRESS, AND PHONE NUMBER.

\_\_\_ 5. YOU MUST CALL MY OFFICE WHEN YOU RECEIVE NOTICE OF ANY AND ALL COURT SETTINGS.

\_\_\_ 6. YOU MUST CALL TO CHECK IN WITH MY OFFICE ON TUESDAY OF EACH WEEK BETWEEN 9:00am AND 5:00pm UNTIL YOUR CASE IS DISPOSED OF. DO NOT CALL BEFORE 9 OR AFTER 5!!

\_\_\_ 7. FAILURE TO CALL AND CHECK IN WEEKLY AND MAKE PAYMENTS AS AGREED WILL RESULT IN A \$15 CHARGE FOR EACH MISSED ONE.

\_\_\_ 8. IF YOU FAIL TO APPEAR FOR COURT, THERE WILL BE ADDITIONAL FEES FOR WHICH YOU WILL BE RESPONSIBLE.
